#### ITEM 5 03/135 MATTERS ARISING

- 5.1 The Committee received the Secretary's report subject to Mr Bracken's clarification that there was no correlation between the extension of Patient Group Directions and the professions' existing rights to autonomous practice.
- 5.2 On minute 4.3 Mr Frowen asked what progress had been made in being able to define the Standards of Proficiency as "minimum standards".

Mr Bracken confirmed that the language in the Order prevented them being defined as "minimum standards".

The Committee agreed that they could properly be described as "threshold standards", and that this was consistent with the wording of the Order.

5.3 On minute 15.3 Mr Seale reported that the new podiatry programme at the University of East London had started and was in the process of seeking approval from the HPC. Ministers had been briefed on the situation. Students had been informed by the programme authorities of their position on an unapproved programme as directed by the Chief Executive.

The resits at University College London for existing students on the approved UCL programme were the normal and proper way of dealing with resits.

5.4 The secretary reported that Prof. A Hazell had now been appointed to the "DH/ Statutory Body Alliance", part of the Department of Health's (England) Partnership Working Arrangements.

#### 9.1 CONTINUING PROFESSIONAL DEVELOPMENT

- 9.1.1 The unconfirmed notes of the meeting held on 18 August 2003 were received.
- 9.1.2 Miss E. Thornton reported on them and drew attention to the request for a general consultative meeting to be discussed at item 12 below.
- 9.1.3 It was agreed that the PLG should link its work to the ten guiding principles of CPD from the Department of Health (England).

- 9.3.2 Prof. C. Lloyd introduced them and explained that work had been carried out up to March 2003 on generic Standards of Education and Training. The PLG's first task was to review this work, and comment was being invited on it. The profession specific SETs would be started after that.
- 9.3.3 Ms Pearson referred the PLG to the former Dietitians Board not to the British Dietetic Association (BDA) for curriculum information. The BDA had never carried out that function.

#### ITEM 10 03/140 RETURN TO PRACTICE

- 10.1 Prof. Klem introduced this item and reported on the meeting of Registration Committee held at 10 am on 24 September 2003.
- 10.2 The Education and Training Committee agreed to recommend to the Council that there be three categories of existing and previous registrants and holders of approved qualifications needing to meet requirements additional to the general registration procedures. These were as follows : -

Less than two years out of practice	No requirements.
Two to five years out of practice	Minimum of 30 days supervised practice and additional study requirements to bring returners up to current standards to meet the Standards of Proficiency.
Five or more years out of practice (including the specific category of those holding an approved qualification more than five years old but who have never been on the CPSM or HPC Registers)	Minimum of 60 days supervised practice and additional study requirements to bring returners up to the level of meeting the Standards of Proficiency.

- 10.3 The scheme was based on self-regulation by those people who had either already been registered or had successfully completed an approved programme.
- 10.4 Return to practice was correlated with the Standards of Conduct, Performance and Ethics. Both applicants and supervisors to stay within their scope of practice when the requirements were being met. Returners did not have to expand or change their scope of practice to comply with the requirements.
- 10.5 The Committee would not seek formally to approve return to practice provision. Returners would self-certify their own supervision and study. It was the intention of the scheme that all existing appropriate provision could be included in it.
- 10.6 The Executive would prepare forms and detailed guidance for submission to the next round of Committees and then the Council on 11 December 2003. The scheme should come into operation after that. The guidance would include the criteria for being a supervisor, advice on self-certification, and suggestions that current return to practice provision from approved educational institutions, from employers and from professional bodies would help meet the requirements. The guidance would explain that " study " must be appropriate, but could be undertaken either formally or privately and that any mode of learning (eg. distance or e-learning) could be considered. Taking appropriate modules of approved pre-registration programmes would also be an option within the scheme.
- 10.7 The scheme would be reviewed after a year in operation.

#### ITEM 11 03/141 <u>CONSULTATIVE MEETING(S) AND THE C.P.S.M's</u> EDUCATIONALISTS FORUM

- 11.1 The Secretary of the Committee introduced the report.
- 11.2 After discussion it was agreed that :
  - a consultative meeting prior to 19 November 2003 would be too soon for the Approvals and SETs PLGs, and
  - a consultative meeting be held for CPD as a half-day morning event at the very end of November, and with the PLG meeting in the afternoon.
- 11.3 The Executive would propose dates for the consultative meetings.

11.4 The CPD meeting must have a very focused brief to explain to participants why it was being held and that they were being asked to provide the PLG with information on their approach to CPD and what they thought of as the key issues.

#### ITEM 12 03/142 COMMITTEE PROCESSES AND OUTPUTS

- 12.1 The Chairman introduced a draft of this paper to be discussed and added to according to members' perceptions. It was designed to inform the Council's discussions on 8 9 October 2003 on the Council's strategic intent document. The paper also included some of the data and issues members had been asking about at previous meetings.
- 12.2 The Chairman reported that there would be an exercise to create syntheses of the experience and issues from approvals work to date. This would be along the lines of the paper submitted at item 13 by the Radiographers Pre-Registration Education and Training Working Group. It would include "Key ratios" and would inform the bodies commissioning education and training. The uni-professional parts would be appended to the overarching report. Work was in hand. The report would require some systematic research to make it as comprehensive as possible.
- 12.3 Issues raised in discussion included :
  - reviewing the Committee's remit and scope of its tasks,
  - the effectiveness of some of the work carried out to date,
  - the need for targets, priorities and strategy and a six-monthly review of them,
  - each Committee meeting to start with a discussion of relevant decisions taken at the previous Council meeting, and monitoring the progress on tasks falling to the Committee, and
  - confirmation that delegation to PLGs seemed to be an effective approach to the Committee's work.

#### ITEM 19 03/149 ANY OTHER BUSINESS : EXERCISE OF FUNCTIONS

- 19.1 Mr Frowen asked whether " grandparent " applicants who claimed to have practised podiatry wholly or mainly for three or more of the previous five years were being referred to " an appropriately qualified assessor " to make judgements about the relevance, safety, and effectiveness of their practice. He suspected they were not being assessed and this was not consistent with protecting the public.
- 19.2 Mr Seale and Mr Bracken reconfirmed the statutory position to put it beyond doubt for the Committee.
  - 19.2.1 The Chief Executive read Part III, Section 4 (2) into the minutes, that, "The Registrar shall have such functions as the Council may direct". The relevant functions in this context had been set out in the paper agreed by Resolution at the meeting of the Committee on 30 July 2003 (Item 8: "Exercise of Functions", Minute 03/114).
  - 19.2.2 Second, the Chief Executive only operated under powers specifically delegated to him by the Council and statutory Committees. He then reported on the exercise of those powers to each Council meeting and in the format agreed by the Council in the Chief Executive's Report item
  - 19.2.3 Third, Mr Bracken stated that there was no power in the Order to refer grandparent applications on the three out of five years basis to assessors without a specific cause for concern. The Order was drafted to allow these applicants to be admitted to the Register by self-certification of the relevance, safety and effectiveness of their practice. This was different from international applicants where the Order did require them to be referred to assessors.

- 19.3 The Committee noted that there was already a procedure for reviewing how the process was operating and bring any concerns to the Committee.
- 19.4 While the other professions acknowledged there might be a potential issue around the inability to refer these applicants for assessment, they accepted the statutory position, the exercise of the Chief Executive's powers, and the review procedures.
- 19.5 Complaints to the Chief Executive about the quality of service at HPC had to refer to specific cases if the Executive was to be able to follow them up. A complaint in the abstract was impossible to deal with.
- 19.6 It was
