<u>RE: The inclusion of the Diploma of Higher Education in Operating Department</u> <u>Practice in the Standards of Education and Training, SET 1: Level of Qualification</u> <u>for entry to the HPC Register</u>

The HPC Register opened for Operating Department Practitioners, on 18th October 2004.

At the Education and Training Committee meeting, held 13th October 2004, the **Diploma of Higher Education in Operating Department Practice** was approved as the UK approved qualification for operating department practitioners with effect from 18th October 2004.

In line with the Health Professions Order 2001 (Article 15.-(1)-(3)) it will be necessary to amend the Standards of Education and Training to reflect the addition of the new profession by making appropriate changes to the threshold entry routes to the Register.

Consequently, the HPC is conducting a 6 week consultation commencing on 28th January 2005 and concluding on 11th March 2005. This puts the HPC's proposal before a range of stakeholders including professional bodies.

Following consultation, and upon approval of the proposal, SET 1 would be altered to read as follows:

1. Level of qualification for entry to the Register:

1.1 The Council normally expects that the **threshold** entry routes to the Register will be the following:

1.1.1 Bachelor degree with honours for the following professions:

- 1.1.2 Masters degree for the arts therapies.
- 1.1.3 Masters degree for the clinical sciences (with the award of the Association of Clinical Scientists' Certificate of Attainment, or equivalent).
- 1.1.4 Equivalent to Certificate of Higher Education for paramedics.

1.1.5 Diploma of Higher Education in Operating Department Practice for Operating Department Practitioners.
