## Item 8.08/183 Key decisions from the Health Professions Council fees consultation

- 8.2 The Council noted that a consultation on the fees proposals had been held between 14 April and 14 July 2008. The key decisions document which was under consideration had also been considered by the Finance and Resources Committee and the Education and Training Committee.

## Item 10.08/185 Changes to the recommendation process for new professions

- 10.1 The Council received a paper from the Executive for discussion/approval.
- 10.2 The paper proposed that the responsibilities of the various tasks that had to be completed before a healthcare profession was statutorily regulated by the Health Professions Council (HPC) were either undertaken in a revised sequence and/or re-assigned between the HPC and the Department of Health (DH).
- 10.3 The key changes to the existing process were that the HPC would consult on the draft Standards of Proficiency, the draft Standards of Education and Training and the proposed protected title(s) prior to making a recommendation to the Secretary of State.
- 10.4 The Council noted that the allocation of the tasks between the HPC and the Department of Health had evolved since the HPC was established in 2001and had not been systematically revised since that time. Recent informal discussions with the Department of Health Regulatory Team had concluded that it would achieve greater clarity and efficiency if the HPC were to undertake more of the tasks before making recommendations to the Secretary of State.
- 10.4 The benefits of the proposed changes included:
  - Clarity of responsibilities
  - A better matching of tasks to organisational expertise
    - A faster process
- 10.5 The changes would have no significant impact on the cost of the process. However, the Council noted that the use of the revised process was likely to have resource implications for the HPC Policy Team. The Executive would address this issue in the HPC work plan for the coming year.
- 10.6 The Council agreed the revised process set out in appendix 2 of the paper.
- 10.7 The Council also agreed to instruct the Executive to seek the agreement of the Department of Health to the proposed changes.

## Action: MJS – October 2008 and ongoing

#### Item 11.011/185 Report from the Continuing Fitness to Practise Professional Liaison Group

- 11.1 The Council received a paper from the Executive for discussion/approval.
- 11.2 The Council noted that the Continuing Fitness to Practise Professional Liaison Group (PLG) had met five times from November 2007 to September 2008. The Group's report to the Council ' Continuing Fitness to Practise – Towards an evidence based approach to revalidation' concluded the PLG's work.
- 11. The President and the HPC Head of Policy and Standards had participated in the Department of Health Non-Medical Revalidation Working Group. This outcome of the work of this group had been the agreement of high level principles and a recommendation that each regulator should give an account of how it would apply these principles by January 2009.
- 11.3 Council noted that the current report's recommendations would align with the principles set out by the Department of Health Working Group and would therefore form the basis of the HPC's response.
- 11.4 The Council approved the report and agreed the recommendations contained within.

## Item 12.08/186 Standards of Proficiency for Radiographers consultation responses

- 12.1 The Council received a paper from the Executive for discussion/approval.
- 12.2 The Council noted that a consultation on a proposed amendment to the standards of proficiency for radiographers had been held between 28 April 2008 and 1 August 2008. The paper included a document summarising the responses to the consultation. The proposal had been that standard 2b.4 should be amended to remove the requirement that diagnostic radiographers should be able to perform standard first trimester ultrasound measurements, as this was not appropriate as a requirement for threshold safe and effective practice.
- 12.3 The Council agreed the following;

(i) the text of the consultation responses document and(ii) the text of the amended standard as set out in the consultation responses document.
