- 4.3 The Group noted that it would be useful if the three chairmen of the Fitness to Practise Committee sat together at future Fitness to Practise Forum meetings.
- 4.4 The President noted the importance of retaining the interest and engagement of members during the period leading up to the implementation of the proposed governance changes. It would be useful if chairmen could remind members of the importance of attending Council and committee meetings.
- 4.5 The Group noted that non-council committee members could attend six additional events which were related to their role as an HPC Council member for which HPC would reimburse an attendance allowance and expenses incurred. These events could include attendance at Fitness to Practise hearings and Council and committee meetings. All members who had not attended training on the Health Professions Order would be invited to attend the next session in the autumn.
