Communications - management commentary

1 Communications projects and activities

HCPC In Focus: From 5 June – 17 July 2015 we conducted an electronic survey to collect feedback from readers. Questions covered the relevance and amount of content, frequency of distribution, areas for future development and general feedback. The responses have provided a starting point for future developments to the newsletter with key findings including suggestions for content and interest in one-off special editions around key pieces of news. The full report has been published on our website.

Media and pr campaigns: Work continues on three key pieces of work. These include 1) promoting hcpc registration: we have surveyed registrants which has provided useful information about which resources they are currently aware of and making use of. These findings will inform the next stages of the project; 2) Signposting: we have researched organisations who either don't signpost to the HCPC online or who refer to HCPC incorrectly, including some professional bodies, charities and employers as well as NHS umbrella organisations. The next step is to tailor our approach to each, making sure they have relevant and up to date information; and 3) Be Sure: we now have a new version of the film which will be used to raise awareness of the Register and the sorts of concerns we deal with. We are finalising the communications plan and working with an external agency to place the film on a range of consumer websites.

2 Communications expertise to departments

Policy: We have developed a communications plan designed to widely disseminate the updated version of Health, disability and becoming a health and care professional which is due to be published later this month. This includes dedicated web pages, a press release and social media as well as targeted distribution to a range of stakeholders including disability and careers services at universities as well as numerous disability charities. We have also targeted collaborative outreach networks which have links to over 4,300 secondary schools and colleges. The Guide will be available in a range of formats and a new video (with British Sign Language interpreting) is being produced drawing on content from the publication.

3 Business as usual communications activities

Events

Meet the HCPC events: The next Meet the HCPC events will take place in Stornoway on 5 October and Fort William on 7 October. The programme will once again include an introduction to HCPC followed by a presentation and workshop on the preventing small problems becoming big problems research.

Communications - management commentary

Employer events: On 9 July we ran an Employer event in Exeter with 24 attendees. The event included presentations on what employers need to know about registration, fitness to practise and the research on preventing small problem becoming big problems. 71% of attendees rated the event overall as good and 29% as excellent. The next event will take place in Cambridge on 12 November.

Education stakeholder event: On 7 October we are holding the second annual education stakeholder event which will focus on the ongoing review of our Standards of education and training. The event will include a presentation by researchers at Keele University on inter-professional education among HCPC-approved programmes. Delegates from education providers, practice educators and professional bodies will be attending.

Media

Statements and reactive lines: we submitted a statement to Community Care magazine in response to a blog piece written by an academic resigning from her university position.

Articles: as well as pieces in Complete Nutrition and Locum Today we have increased the content for the HCPC blog including articles on the Education and Training Committee, FTP concerns, HCPC registration, FTP advice for employers and a welcome from Anna (former Chair) to Elaine (our new Chair). We are now posting at least 2 articles every month and in August had over 6000 page views.

Publishing

The following have been published:

- Practitioner psychologists Standards of proficiency: revised standards published on Wednesday 1 July 2015.
- Annual report and accounts 2014–15: published on Friday 17 July.

The publishing team have also worked on the following:

- Health, disability and becoming a health and care professional (final draft signed off and gone to print)
- The making of a multi-professional regulator (first draft sub-edited and sent to our designers)
- Fitness to Practise annual report (publication due November 2015)
- Education Update newsletter (publication due 12 October 2015)

Stakeholder

Parliamentary monitoring and engagement: Three further parliamentary questions have been tabled regarding the fee rise, and the fees of other regulators, in both houses of the UK Parliament as well as the devolved assembly in Wales. Responses from the Department of Health have pointed to the fact that the HCPC has the lowest registration fee of the nine regulators overseen by the PSA. In the House of Lords, Lord Hunt of Kings Heath filed a regret motion relating to the fee rise. The issue will now be debated in the House of Lords although a date has not yet been set. There have also been several questions relating to the introduction of the Law Commission Bill and we will continue to monitor any developments on this issue. In the Scottish Parliament, the issue of adding clinical associates in applied psychology to professions regulated by the HCPC was also raised. The response pointed to the Command Paper, Enabling Excellence, and the preference for voluntary registers over statutory regulation.

Meetings with the professions: During this period, we held our annual meeting for the Chief Executive and Chair of HCPC with representatives of the Institute of Biomedical Science, and the Chartered Society of Physiotherapy on Wednesday 2 September. The Stakeholder Communications Manager also met with the incoming Assistant Director of Marketing and Communications at the College of Occupational Therapists on Friday 14 August. In the field of social work, the Stakeholder Communications Manager attended the ADASS Workforce Development Workshop on Friday 3 July, which looked at setting priorities and objectives for the group.

Conferences and presentations: The Stakeholder Communications Manager gave presentations at Epsom General Hospital on Wednesday 24 June, at the Association for Perioperative Practice Annual Conference in York on Friday 31 July, the Independent Hearing Professionals Annual Conference in Birmingham on Friday 4 September and at an AHP Study Day on Thursday 10 September at Southport and Ormskirk Hospital NHS Trust. He also attended the Patient Safety Congress in Birmingham (Monday 6 and Tuesday 7 July) as a delegate. On Tuesday 23 June, we delivered two sessions at NHS England's inaugural Chief Allied Health Professionals Conference. The theme of the Conference was innovation and entrepreneurship, and the HCPC Chair and Stakeholder Communication Manager led workshops considering how regulation supports innovation.

Wales: On Friday 19 June the HCPC Chair and Stakeholder Communications Manager met with the Lead AHP for Wales and colleagues in the Welsh administration, and attended the Directors of Therapies meeting. On Tuesday 21 July the Stakeholder Communications Manager presented the HCPC's research on 'preventing small problems from becoming big problems' to the Wales Concordat Forum.

Gibraltar: Following the signing of a Memorandum of Understanding with the Gibraltar Health Board earlier this year, the Stakeholder Communications Manager ran three well-attended sessions on the Council's CPD requirements in Gibraltar on Wednesday 1 July 2015.

Communications – management commentary

Engaging with patient, service user and carer representative organisations: following on from the Ipsos MORI research, brought to Council in February this year, we are beginning a piece of work to build relationships with a number of organisations which will allow us to share information and explore ways of working together. To date, we have identified a number of stakeholder organisations and have begun contacting and meeting with them.

Web and digital

Web deployment: Testing for this deployment, which refreshes the home, online register and audience pages, will complete in early September with a live release expected later this month. The refresh also makes the website more responsive to mobile devices.

Website review: With the help of an external supplier, we are conducting a review of the current website and existing stakeholder research to produce high-level recommendations to inform the business case for a major project to build a new HCPC website.

Email marketing: Having introduced new software to manage our bulk email, we have been setting up design templates for the different mailings that we produce. These include internal and external newsletters, Issues Brief, consultation emails and communication with HCPC Partners. We have sent 25 email campaigns during this period.

Web and digital requests: We had a total of 152 web and digital requests, including intranet video guidance for Outlook and updates to standards on the website and the myHCPC app.

Internal communications

Internal communications and engagement plans have been developed to support 1) the HR and Partners build project - this involves a range of communications activities to raise awareness of the project and to support the training of all employees and partners on the new system and 2) the Registration transformation and improvement project - this is a long term project (2015 – 2019) and the plan will be reviewed regularly. A key focus for communications activity will be National Customer Service week which takes place 5-9 October.

Employee farewell to Anna van der Gaag: On 8 September we held an internal event to give employees an opportunity to say thank you and goodbye to Anna. We presented Anna with a book, which contained photos of her time as Chair and messages of best wishes from all employees.
