### Council, 6 December 2017

### **Chair's report to Council**

This paper provides Council with a summary of the activities that the Chair has undertaken since the last Council meeting. A list of meetings attended since the last report was considered by Council are all listed within the appendix.

#### **Meetings and events**

During October, the Chair spent four days in Northern Ireland where she met a number of colleagues including the Chief Allied Health Professions Officer, representatives from the Northern Ireland Social Care Council and the Chief Executive of the Regulation and Quality Improvement Authority.

The HCPC also hosted a stakeholder event in Belfast, where an overview of the organisation was presented, along with the highlights of recently-published research into strategies to prevent fitness to practice concerns. The event provided an opportunity for Council and executive members to network with a broad range of stakeholders from across Northern Ireland.

In addition, Council and the Executive management team had a very successful development session in Northern Ireland identifying the key priorities which will inform the corporate business plan. This is currently being refined, with a draft to be considered at the Council meeting in February.

Several HCPC colleagues including the Chair and two Council members attended and contributed to the annual Scottish regulatory conference on 30 October. Contributions included presentations, panels and a stand which was well attended by delegates.

The Chair and Chief Executive continue with their ongoing schedule of meetings with professional bodies. These provide an opportunity to hear about the contemporary issues facing different professions and to discuss regulatory topics such as the consultations relating to Medical Associate Professionals and the future shape of regulation, the transition to Social Work England and to highlight new research and guidance published by the HCPC.

Meet the HCPC events continue to be well attended by registrants with a variety of themes being discussed including CPD, strategies for preventing Fitness to practice concerns and the expanding role of many Allied Health Professionals. Similar topics were discussed at the employer event held in Manchester, again this was well attended and engaged employers from a range of sectors. Very positive feedback

was received from delegates about the informative nature of the presentations and the opportunity to discuss specific scenarios with HCPC colleagues.

#### **Council Recruitment**

Since the Council meeting in September, the recruitment process for a new Lay member of Council concluded and Kathryn Foreman has been appointed by the Privy Council and will start on 1st January 2018. We also say goodbye to one of our longstanding members of Council – Nicky Wood, who has been with us since January 2014. Her contribution to the business of Council and the Remuneration Committee has been significant. We wish her great success with her future plans.

### **Ongoing activity**

The governance review continues to make good progress with committees having refreshed their terms of reference and reflected on future work plans. The final two independent members have been recruited to join the Education and Training Committee and the Committee's composition is subject to Council ratification later today. An induction session for all independent committee members will take place in January 2018.
