- (i) That the majority of new staff in the Department of Physiotherapy Education to support the scheme be appointed by January 2003;
- (ii) That the proposal documentation articulate the relationship between the weighting of assessment and the allocation of credits both in terms of ensuring that the module assessments fairly reflect the credits allocated and the relationship between assessments and the award of module credits. Such assessment and progression criteria should also be provided in a format that may be easily understood by students. Furthermore, the document should be amended in order to provide consistency throughout and certain factual and grammatical errors corrected in accordance with a list to be provided to the department;
- (iii) That the scheme be subject to a full review after a period of two years has elapsed since its introduction.

It was agreed that condition (ii) should be satisfied by 7 November 2002.

6. Recommendations

(i) That a diagram be produced to articulate the module-teaching pattern during each week of the scheme;

(ii)	That particular consideration be afforded to providing appropriate support to overseas students admitted to the scheme with a British Council/UCLES/IELTS English Language Score of less than 7;
(iii)	To closely monitor the Life Sciences 1 Module at Level 1 to determine whether it continues to be appropriate and realistic for 31 separate Learning Outcomes to be prescribed to this one module;
(iv)	To monitor the student experience on the scheme through student evaluation and other feedback mechanisms;
(v)	To incorporate e-learning and e-teaching into the Learning and Teaching Strategy for the scheme;
(vi)	To clarify the procedures for both defining the Learning Outcomes for the elective placement and for the retrieval of any failure of an elective placement;

- That the programme team revise the documentation to read "eligibility for state registration" where the term "licence to practise" is currently used and that any references to the Council for Professions Supplementary to Medicine" be amended to the "Health Professions Council".

The volume of students entering the flexible route programme be carefully monitored; that the resource impact of admitting students to the flexible route must be reviewed and that a cap on students numbers be set for each academic year.

 WELCOME & APOLOGIES 89. Apologies were received from Lynn Clouder, Carolyn Edwards, John Harper, Louise Jones, Valerie Maehle and Nigel Palastanga. 90. The minutes of the meeting of the Joint Validation Committee held on Thursday 18th July 2002 were confirmed as an accurate record of the meeting following a correction to the new intake for Liverpool University which should read 45 and not 50.

MATTERS ARISING

- i) Accreditation of Clinical Educators (minute 61)
- **91.** The latest developments in relation to the Framework for the Accreditation of Clinical Educators was reported. It had been decided to propose two routes to accreditation all based on meeting the nine outcomes of the framework one for new clinical educators which would involve completion of a course accredited by the CSP and the other for experienced educators involving the submission of reflective statements similar to the ILT application process for experienced educators. This would then be adapted for use by those wishing to gain reaccreditation. It was intended to pilot the experiential route between February and April 2003 with a view to launching the scheme in May 2003.
- **92**. It was noted that a similar scheme of accreditation had been operating in the North West for two years, but that this also involved accreditation of the site as well as the educator. Whilst the benefits of accrediting sites as well as educators was appreciated, it was confirmed that at this stage it was only proposed to accredit the educators themselves.
- **93.** It was noted that the Student Executive Committee had concerns about the wide variations in standards of clinical education. It was agreed that accreditation would be included on the next SEC agenda for discussion.

HPC update (minute 62)

94. It was noted that the CSP's response to the consultation document had Been submitted by 30 September 2002 and that the committee's Responses at the last meeting had been included. The issue which had Produced the most responses from members were how overseas qualified Physiotherapists gain state registration (or not), and pleas for the Introduction of a more rigorous yet equitable system. The other issue of major concern to members was the closure of the register. It had been implied originally that only practising clinicians would be eligible for inclusion within the register since it was considered only they would be competent and safe to practise on the public. It was evident that the HPC had not thought through major issues such as competence in Relation to CPD, and had now sought legal advice on this which Interpreted "competence" much more broadly and therefore members who were primarily managers, educators or researchers would be eligible for inclusion.

standards of proficiency for each profession to be produced. A group had been formed – a multi-professional group which separated off into smaller, uniprofessional groups to devise individual professional standards of proficiency. Their starting point was the QAA benchmark standards published in 2001, the CSP Standards of Physiotherapy Practice, Rules of Professional Conduct and National Occupational Standards. The overall aim was to articulate a profile of competence necessary for effective, safe and legal practice and it was felt that this approach would provide a working link between the task in hand and work completed previously and work currently ongoing. They were also looking at the statements of standards of proficiency produced by the General Osteopathic Council and the General Chiropractic Council. The standards of proficiency had to be in place by 1 April 2003. They would also be essential to make decisions on grandparenting.

HPC EDUCATION AND TRAINING COMMITTEE (ETC) REPORT

96. Following a meeting of the ETC on 12 November 2002, it was understood that the professions might be asked to take forward work on the value statement considered by JVC in May 2002, to which the other professions had signed up. It was further understood that the professional bodies and the HPC would maintain their existing arrangements for validation and approval beyond 1 April 2003. Ideas for proceeding could be contributed to the next ETC meeting on 27th November 2002.

97. It was noted that the HPC was making its final amendments to its response to the Consultation document before it went for printing. HPC's response was due to be formally launched on 9 December 2002 in Cardiff, but a meeting of professional bodies had been convened in London on 6th December to give advanced notice of the sponse.

UPDATE ON QAA PROTOTYPE REVIEW EVALUATION

98. It was reported that at the next meeting of the QAA prototype review steering group the evaluation of the 2002 prototype subject reviews would be available for discussion. The major difference at this review was the emphasis placed on clinical education. It was also noted that with the reviews being spread out over a longer period, it had been more difficult to co-ordinate reviewers' availability for meetings. The Department of Health was now tendering for its subject review work and it would not necessarily be granted to QAA which raised the prospect of universities being subjected to yet another layer of quality assurance review. The Department of Health was re-considering its role in quality assurance and there was an implication that it wanted to remove professional bodies from the process. This made the need to work closely with the regulatory body more important. The role of NHS University was also unclear. It was reported that a Memoradum of Co-operation had just been published stween Universities UK and the Department of Health which indicated that NHS

University was not in the business of pre-registration education.
