## **ASSESSORS' FEES (Revised Paper)**

A revised paper is appended due to an incorrect assumption made concerning the number of likely cases for the rest of the year.

If we maintain rates as at present, we anticipate that there will be an overall saving of £9,524.

Putting up fees to  $\pounds 60$  will result in an overspend of  $\pounds 71,836$  in 6 months -  $\pounds 59,863$  if implemented on  $1^{st}$  November.

The Finance & Resources Committee is therefore requested to determine that Assessors' Fees should be increased to £60 with effect from 1<sup>st</sup> November, mindful of the likely overspend.
