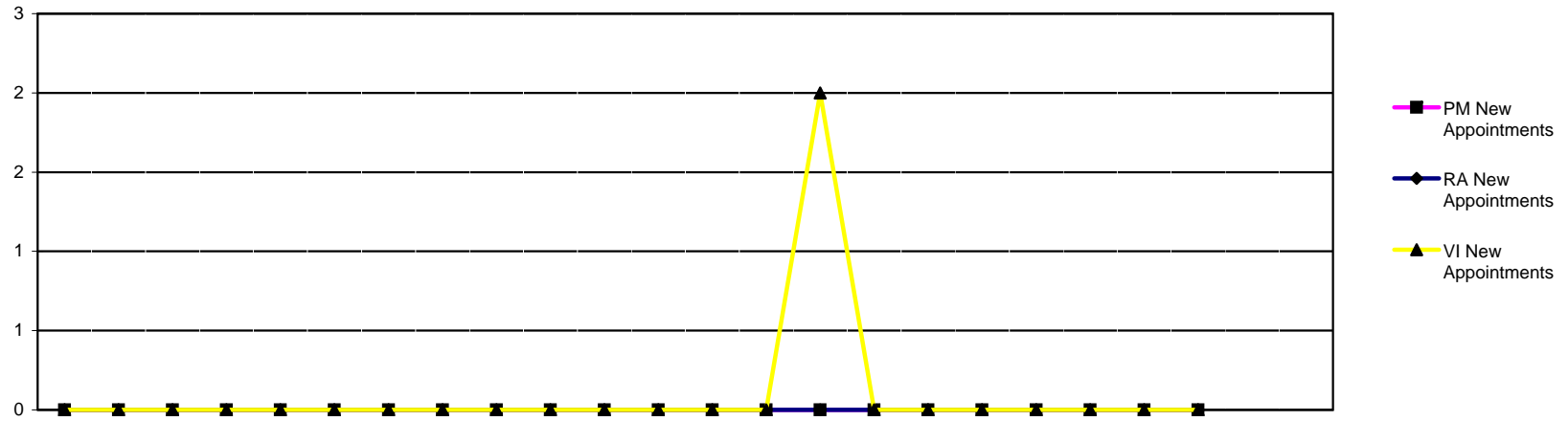
### Prosthetists and Orthotists Recruitment
